# 1. Memorandum of Understanding

#### WHEREAS:

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

## 2. Scope of the MoU

- A) Training for Students: First Party will actively engage to help the delivery of the Engineering services Training for students of the Second Party. The First Party does not assure placements instead agrees to share the information on any interview/recruitment in the relevant field to the students of the Second Party.
- B) **Training Program Forecast:** Both Parties have agreed to carry out the training program with immediate effect, as it is for the greater good of the students in the B.Tech Aeronautical /Aerospace Engineering Program.
- C) Certification: On successful completion of the Training Program, students of the Second Party will receive a course completion/Internship certificate recognized by SS Technologies, attested by concern Expertise.
